Some anticipated discussion at the meeting may include:

Input on proposed quarterly, as opposed to monthly, member matches. These matches may represent mini-formatted matches from our four main disciplines. This may allow new members or newer shooters to familiarize themselves with these disciplines in a more informal setting. We will need help, hopefully from discipline directors/shooters, setting up for these mini matches.

Discussion on where steel targets will be allowed and how such targets are to be set up and used. (See added discussion below).

Discussions regarding range traffic and the elimination of the shoot house access from behind the 200 yard berm.

Bring your ideas and enthusiasm to the next meeting so as to better enhance the discussions.

#### **Steel Targets**

Long time member Steve Byerly attended the Jan. 31 EC meeting and gave them a polite "what for" (an old Dickensian term – sorry) as regards recent Range Use manual (RUM) changes as regards steel target use. While conceding that Bay 2 was not a good location for steel target use, he proposed that the older restrictions allowing member owned steel targets in Bays 3, 4 & 5 (with relevant caveats) as well as at the bank on the 300 yard rifle range have worked well over the years and should be continued.

Steve also indicated we should update the RUM further as regards target use and safety. The EC agreed and has initiated the RUM upgrade process and decided to allow the use of steel targets at the back berms (banks) in Bays 3, 4 & 5 and at the bank of the 300 yard rifle range – and ONLY at the bank. Our thanks to Steve for stepping up and being heard!

NOTE: Steel target use is a serious and ongoing safety issue. Any member found to be improperly using steel targets will face disciplinary action. If there are any questions concerning proper use of steel targets – ask our Range Officer first!

NOTE: Steel targets need to be as close to the back berm (bank) of each allowable location as possible. Steel target should never be fired on at an angle.

NOTE: <u>Club owned</u> steel targets are NOT for general membership use. Only for the use of respective disciplines. DO NOT move or use any club owned steel targets – period. Anyone found using club owned steel targets will face disciplinary action.

#### **Rimfire Benchrest**

The January match was a blustery affair and only seven or so souls were brave enough to attend. The first two flights were not nearly as bad as anticipated, but by the third flight, with the cold rain moving swiftly in, even the brave souls turned tail and skedaddled.

Come on out for the next match on February 13th and have some fun. Five dollars per rifle. All welcome!

#### **Rifle Range**

Every bench position (1-15) is marked and corresponds to a specific target position. While the target positions are not marked, it is not rocket science to determine the corresponding target position by observing the target pole pipes in the ground. The two far right target pipes, looking down range, are for the bench rest position 15 ONLY. The next two pipes are for benchrest position 14 – and so on. It is not uncommon to see shooters place their targets in the target pipes at far right (for use by bench position 15 ONLY) and then shoot from a bench rest position such as bench number 1-3. It is hard to comprehend how any shooter cannot notice that their bullets will cross the creek (strictly prohibited by the way) and not impact the bank at three hundred yards (between the red and white markers). Do not allow rifles to be aimed or allow bullets to impact anywhere other than into the back berm at three hundred yards between the red and white markers PERIOD. If any member sees this happening, PLEASE notify the shooter immediately, get the shooters member number and report the member to the Range office and make an incident report in the clubhouse. Any shooter reported can expect to receive a most serious disciplinary action. There is NO EXCUSE for doing this.

#### **Bay 2 Violations**

Bay 2 is not to be used as an action pistol bay. Such use is reserved for Bay 5 only. Read the Range Use manual. Members have been observed laying over the benches and shooting, moving and shooting at odd angles where bullets may not impact the proper back berm, and sitting on the ground shooting between their legs. All of these incidents are prohibited.

#### **Quonset Hut**

The Quonset hut is for rimfire use only – as clearly indicated in the Range Use Manual. I have some free time so let me quote the Range Use Manual language for you.

"It is a .22 caliber Rim-Fire and Air Rifle only range. Ammunition is restricted to .22 short, .22 long, and .22 long rifle. Air rifles of up to .25 caliber are permitted. Only lead airgun pellets are allowed. Steel "BB's" are specifically prohibited. The use of all other ammunition is prohibited because the bullet traps are constructed for .22 rimfire caliber ammunition only. Unapproved ammunition will damage this structure and may injure the shooter."

It has become apparent that members or their guests have been shooting .380 & 9mm firearms in the Quonset Hut. This is CLEARLY prohibited. Why would anyone be so brazenly ignorant? Follow the rules and do not disregard safety. Read your Range Use Manual.

#### **Trash**

The amount of trash and debris being left lying around is becoming abusive. Please take pride in your club. There are plenty of trash receptacles made available for member use. Make use of them.

#### Range Closed February 11 & 12

From 12PM on Friday Feb. 11 through February 12, the range will be closed for a Hunter Safety Scrimmage.
